**PRIVACY NOTICE REGARDING THE PROCESSING OF PERSONAL DATA THROUGH**  
**THE WEBSITE CONTACT FORM**

As Koluman Otomotiv Sanayi Anonim Şirketi ("KOE"), which has the status of 'data controller' in accordance with the Law on the Protection of Personal Data No. 6698 ("KVKK" or "Law"), we collect, process and transfer your personal data under the conditions explained in detail below.

With this text, KOE enlightens you, the data owners, who are defined as 'relevant persons' in the Law, about the collection, processing and transfer of your personal data through our company's internet access networks and your rights within the scope of the Law.

### **1. Data Controller**

KOE determines the purposes and means of processing your personal data by acting as the 'data controller' defined in Article 3/1-(i) of the Law in the processing processes of your personal data.

As the data controller, KOE is obliged to establish and manage the data recording system and to take administrative and technical measures regarding data security. In this context, it will also be able to process your data to third parties with the status of 'data processor' defined in Article 3/1-(1) of the Law.

### **2. Processed Personal Data**

As a KOE employee, visitor and/or customer, your identity (name surname) and transaction security (IP information, username, MAC address, IP information and internet traffic) data are processed with your access to our company's internet networks.

### **3. Purposes and Methods of Collecting Your Personal Data**

Your personal data is collected by KOE in electronic media within the scope of the legal reasons and processing purposes described below.

### **4. Processing of Your Personal Data, Legal Reasons and Processing Purposes**

Your personal data collected by KOE, KOE's 5651 p. In order to perform the obligations arising from the secondary regulations published by all relevant national/international legislation and national/international authorized authorities based on these, especially the Law on the Regulation of Broadcasts Made on the Internet and Combating Crimes Committed Through These Publications, it is processed in accordance with the principles in Article 4 of the Law, within the processing conditions regulated in Article 5.

### **5. Persons to Whom Your Personal Data is Transferred and Purposes of Transfer**

Your personal data collected by KOE may be transferred to the person or organizations (BTK, MASAK, judicial and administrative authorities, other official institutions and organizations and

persons) with the right and authority to request and process personal information within the scope of the said legislation or contracts that are allowed by the legislation and/or the contracts made to, within the framework of the personal data processing conditions and purposes specified in Article 8 of the Law.

## **6. Your Legal Rights**

As a personal data owner, in accordance with Article 11 of the Law, by applying to KOE as the data controller;

- Learning whether your personal data has been processed,
  - If your personal data is processed, request information about it,
  - To learn the purpose of processing your personal data and whether it is used in accordance with its purpose,
  - To know the third parties to whom your personal data is transferred at home or abroad,
  - If your personal data is processed incompletely or incorrectly, to request the correction of the transactions made in this context and to request that the transaction made in this context be notified to the third parties to whom the personal data is transferred,
  - To request the deletion or destruction of personal data within the framework of the conditions stipulated in Article 7 of the Law (although it has been processed in accordance with the provisions of the Law and other relevant laws, in case the reasons requiring the processing of your personal data disappear) and to request that the transaction made in this context be notified to the third parties to whom the personal data is transferred,
  - Objecting to the emergence of a result against you by analyzing your processed data exclusively through automatic systems,
- You have the right to request the removal of the damage in case you suffer damage due to the unlawful processing of your personal data. The exceptional circumstances stipulated in Article 28 of the Law are reserved.

Your request will be finalized as soon as possible and in any case within thirty (30) days at the latest, if it requires an additional cost, as a rule, but for the fee in the tariff determined by the Personal Data Protection Board.
