Your personal data is collected, processed, and transferred by Kulman Otomotiv Endüstri Anonim Şirketi (“KOE”) as the data controller in accordance with the Law on the Protection of Personal Data No. 6698 (“LPPD” or “Law”) under the terms outlined in the *Kulman Otomotiv Endüstri Anonim Şirketi Personal Data Protection and Processing Policy* (“Policy”) published at <https://www.kulmanotomotiv.com/tr/kurumsal>.

1. Legal Basis of Your Right to Apply

It is regulated by the Article 11 of the Law, data owners (“data owner”) have certain rights, including those listed in the same article, and may exercise these rights by applying to the data controller. These rights are detailed in Article 3.2 of the Policy and the relevant *Clarification Text*.

The procedures and principles regarding your (as data owners) applications to KOE (as the data controller) are regulated under Article 13 of the Law and the *Communiqué on the Principles and Procedures for Application to the Data Controller* (“Communiqué”).

According to Article 13 of the Law and Article 5 of the Communiqué, data subjects may submit their requests via one of the following methods:

- (i) in writing,
- (ii) through a registered electronic mail (KEP) address, secure electronic signature, mobile signature, or via the email address previously notified to and registered in the system of the data controller,
- (iii) through software or applications developed for the purpose of application.

2. Application Channels and Methods

As the data owner, you may submit your requests under Article 11 of the Law by completing the attached **Application Form** *completely and accurately*, and sending it to KOE through one of the channels listed below.

If your request is accepted, it will be fulfilled as soon as possible, and you will be informed accordingly. In case your request is rejected, you will be informed with an explanation of the reasons for rejection.
